The Government's Gift Aid scheme allows us to reclaim the tax on your donations to the hospice. If you are a UK taxpayer, by completing the form below we can claim Gift Aid on your donations, which will increase their value by 25% – **and it won't cost you anything.**

- If you pay tax at the higher rate you can claim further tax relief in your Self Assessment tax return.
