Our Celebration Tree is a beautiful copper sculpture, displayed in the main reception of our Little Hulton hospice. It offers you a wonderful way to celebrate those who are special to you with a dedicated leaf or plaque.

The tree is decorated with a selection of gold, silver and bronze leaves, as well as a number of bird plaques. The leaves and birds can be engraved with a name to celebrate anyone who has links with St Ann's, whether they've worked or volunteered here, been a patient, are a current patient or support us in any way.

Each leaf or bird plaque you dedicate will enable us to continue providing excellent care and support to local people, when they need it most.

You can make your dedication with a one-off donation or in monthly instalments. It will remain on our tree for a year and after that time we'll invite you to either renew your donation to keep it on the tree, or take your plaque home. Each leaf will include the wording "In Celebration of" and there is space for your dedication.
